

“NBC13 HD THROWS A WEDDING”

REVISED OFFICIAL RULES

June 26, 2008

“NBC13 HD THROWS A WEDDING” (“Contest”) is sponsored by Media General, Inc., its affiliate or subsidiaries, including but not limited to Birmingham Broadcasting LLC (“WVTM/NBC13 HD”), Ford Motor Company, and Birmingham Magazine (collectively “Sponsors”).

Entrants agree to be bound by these Official Rules and by the decisions of the Sponsors and judges, whose decisions are final. Failure to comply with these rules may result in disqualification. WVTM/NBC13 HD reserves the right to disqualify any person it believes has intentionally violated these rules.

1. PRELIMINARY INFORMATION

WVTM/NBC13 HD is offering a Grand Prize consisting of a wedding, honeymoon and 2-year vehicle lease to be awarded to one couple (“the Wedding Couple”). The entries who will be judged and the Wedding Couple will be selected by WVTM/NBC13 HD. The wedding will be recorded for broadcast on WVTM/NBC13 HD. Grand Prize is described in greater detail in Section 8.

Anyone considering submitting an application form to participate in this Contest should read all of the information below for eligibility rules, requirements of participation and an explanation of what the Wedding Couple will receive as part of the Grand Prize.

Please note that all entrants must be willing to, among other things:

- make a one to two-minute video explaining why WVTM/NBC13 HD should throw your wedding;
- make yourself available to be interviewed and videotaped by WVTM/NBC13 HD between 15 and 20 times;
- provide all of the information required in the entry form;
- allow WVTM/NBC13 HD to conduct a background check on you; and
- appear on WVTM/NBC13 HD several times if selected as a Wedding Couple.

The Wedding Couple must agree, among other things:

- to make themselves available for multiple appearances on WVTM/NBC13 HD and for related publicity and promotions;
- to agree to have your wedding recorded for broadcast on WVTM/NBC13 HD on a date chosen by WVTM/NBC13 HD and at a venue selected by WVTM/NBC13 HD (currently scheduled for October 9, 2008 at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205, but both venue and date are subject to change in the sole discretion of WVTM/NBC13 HD);
- to agree that WVTM/NBC13 HD, its viewers and others will decide upon all elements of the wedding, without input from the Wedding Couple; and

- to depart for a honeymoon arranged by WVTM/NBC13 HD.

The requirements detailed in these Official Rules cannot be waived or changed except by WVTM/NBC13 HD, and entrants who cannot perform these requirements or make the necessary time commitment, or whose religion does not permit a marriage outside of a religious dwelling, should not submit an entry form.

PLEASE NOTE: This Contest is open only to unmarried couples (defined as one male and one female) who have been engaged to each other for at least one month immediately prior to entry, are legal residents of any of the following Alabama counties: Marion, Fayette, Pickens, Greene, Hale, Tuscaloosa, Walker, Winston, Cullman, Jefferson, Bibb, Chilton, Shelby, St. Clair, Blount, Etowah, Cherokee, Calhoun, Talladega, Coosa, or Clay, are 21 years of age or older as of July 28, 2008 and who comply with the additional requirements set forth in these rules. The Entry Phase of the Contest begins on May 22, 2008 at 5:00 AM and ends on July 28, 2008 at 12:00 PM (“Entry Period”). The Wedding Couple will be chosen on July 29, 2008 or within a reasonable time thereafter and they will be notified by WVTM/NBC13 HD within a reasonable time after the selection has been made. The Wedding Couple will be announced on WVTM/NBC13 HD on or about Tuesday, July 29, 2008. All times in this Contest refer to Central Time (“CT”).

No purchase necessary. Void where prohibited or restricted by applicable federal or state laws and regulations.

2. TO ENTER

To enter, please follow these three steps:

(a) Print and complete an application form available at www.NBC13.com. The application form consists of a series of questions, including name, address, e-mail address, background information about each of the individuals involved, family information, and other detailed and personal information.

(b) We want to see you, so make a video on either VHS, DVD, mini DV, or CD-ROM. introducing yourselves, telling us your date of engagement and explaining why WVTM/NBC13 HD should throw you a wedding (the “Video”). The Video should last no longer than two (2) minutes. Both members of the couple must be present in the video. No digitally altered or enhanced video is permitted. No watermarks, signatures, or copyright notices may be added to the videotape. Any individuals who appear in your videotape must give written permission for the use of their image if their face is shown and you must agree to provide those written permissions to WVTM/NBC13 HD if requested.

**If you prefer for WVTM/NBC13 HD to create your video, you may schedule an appointment for your video to be made by us. Simply call WVTM/NBC13 HD at 205-558-7251 to schedule your appointment. Be sure to allow for at least 72 hours turnaround time to get your appointment scheduled and completed in time to meet the entry deadline.

**You may also have your video created by WVTM/NBC13 HD by appearing at events where WVTM/NBC13 HD will be videotaping. Stay tuned for future announcements of these opportunities!

(c) Submit your entry to WVTM/NBC13 HD as follows: Print your name, address, telephone numbers (daytime and evening) and e-mail address on a label, and affix the label to your Video. Place BOTH the Video and your application form (“Application Materials”) in a single package and send the package to WVTM/NBC13 HD as instructed below. *No other methods of entry will be accepted.*

MAIL-IN ENTRY: Mail your Application Materials to NBC13 HD THROWS A WEDDING c/o WVTM/NBC13 HD, 1732 VALLEY VIEW DRIVE, BIRMINGHAM, ALABAMA 35209.

HAND-DELIVERED ENTRY: Place your Application Materials in a single package labeled: “NBC13 HD THROWS A WEDDING” and hand-deliver it to the WVTM/NBC13 HD STUDIOS, 1732 VALLEY VIEW DRIVE, BIRMINGHAM, ALABAMA 35209, Monday through Friday, 9 AM to 5 PM.

Regardless of the method of entry, all entries must be received by WVTM/NBC13 HD no later than 12:00 PM CT on Monday, July 28, 2008. Limit one (1) entry per outer mail envelope or package. Sponsors are not responsible for lost, interrupted, or unavailable network, server, or other connections, or for any failed telephone or computer hardware or software, or for any failed, delayed, misdirected, corrupted files, for distorted, unplayable, corrupted, damaged, or incompatible video submissions, for late, lost, undelivered, misdelivered or misdirected, postage-due, improperly labeled, mutilated, illegible, or for errors of any kind, whether human, mechanical, or electronic, or for entries, Video or Application Materials that for any reason are not received by WVTM/NBC13 HD in complete form by the deadline stated above.

Limit 1 entry per couple. Multiple entries received from any couple thereafter will void all such additional entries. Entries that are incomplete, illegible, damaged or corrupted are void and will not be accepted. All entries, including Application Materials and Videos, become the property of WVTM/NBC13 HD and will not be acknowledged or returned.

By entering, you and everyone appearing in the Video agree that the Video may be broadcast on WVTM/NBC13 HD and in promotions and advertisements for WVTM/NBC13 HD. Videos must be original, truthful, unpublished, created solely by the submitting entrants, must not have been submitted in any other competition or contest (including any prior wedding contest whether hosted by WVTM/NBC13 HD or any other sponsor or promoter), must not include any photos, film or other images that are not originally taken or created by you and must not infringe upon any rights of any third party, including but not limited to copyright, trademark, and rights of privacy and publicity. By submitting Application Materials to “NBC13 HD THROWS A WEDDING,” entrants are not submitting an application for employment. By submitting your video, you give Sponsors a perpetual, worldwide, non-exclusive license to use, reproduce, broadcast, rebroadcast and exploit such material in any media now or hereafter discovered, including on the Sponsors’ various websites. If WVTM/NBC13 HD created your video, you acknowledge that WVTM/NBC13 HD owns all right, title and interest in such video.

By submitting the application, entrants agree to receive e-mails and/or other materials from WVTM/NBC13 HD regarding this Contest.

3. ELIGIBILITY CRITERIA

To enter and to be eligible to receive the Grand Prize, entrants must meet the following eligibility requirements as of July 28, 2008:

- each couple submitting a completed application form must consist of a male and a female, each of whom is unmarried and at least 21 years of age;
- the couple must have been engaged to each other to be married for at least one month immediately prior to July 28, 2008;
- each individual must be a legal resident of one of the following counties: Marion, Fayette, Pickens, Greene, Hale, Tuscaloosa, Walker, Winston, Cullman, Jefferson, Bibb, Chilton, Shelby, St. Clair, Blount, Etowah, Cherokee, Calhoun, Talladega, Coosa, or Clay;
- each individual must not be subject to any travel restrictions and must agree to obtain the requisite travel-related immunizations, if necessary;
- each of the individuals must be of good moral character, must have never been convicted of a crime of any nature (other than moving violations of a misdemeanor type that did not involve personal injury, drugs or alcohol), and must have nothing in their background that would be an embarrassment to WVTM /NBC13 HD as determined by WVTM/NBC13 HD in its sole discretion;
- each entrant must be willing to undergo a background check conducted by or on behalf of WVTM/NBC13 HD and to sign waiver forms authorizing the release of personal and background information to WVTM/NBC13 HD for that purpose;
- each entrant must be willing to have their wedding ceremony performed on or about October 9, 2008 (date subject to change in WVTM/NBC13 HD's discretion), at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205 or such other venue selected by WVTM/NBC13 HD in its sole discretion and without input from the Wedding Couple;
- each entrant must be available to travel by airplane, automobile, boat, helicopter, train or any other vehicle of WVTM/NBC13 HD's choosing to an undisclosed location given approximately 24 hours' notice;
- each entrant must not be an elected official and must not be currently running for any political office (local, state or federal);
- each entrant must be willing to sign an affidavit attesting to the truth of the facts in the application form and Video and attesting that each entrant meets all the eligibility requirements; and
- Each entrant must be willing and able to fulfill all other obligations that are set out in these Official Rules

Employees of Media General, Inc., its affiliates or subsidiaries, including but not limited to Birmingham Broadcasting (WVTM-TV), LLC, Ford Motor Company, Birmingham Magazine, any contributing wedding partner organization, and their respective advertising and promotion agencies, their parent, subsidiary and joint venture companies, as well as members of their immediate families (defined as spouse, parents, children and siblings) and households (whether or not related) are not eligible to enter or win.

4. WEDDING COUPLE OBLIGATIONS

The Wedding Couple must also be willing to undertake the following without additional compensation:

- to be interviewed by telephone, and to consent to the broadcast on television by WVTM/NBC13 HD of all or part of such interview, and to either appear in a videotape produced by WVTM/NBC13 HD or to submit a videotape in which the Wedding Couple appears;
- to make themselves available to be interviewed in Birmingham by WVTM/NBC13 HD at times and dates selected by WVTM/NBC13 HD in its sole discretion;
- to make themselves available to appear on WVTM/NBC13 HD at least up to twice a week for a period of up to 16 weeks;
- to make themselves available for videotaped appearances to air on WVTM/NBC13 HD, and to ask friends and family to appear as well;
- to make themselves available to attend and participate in fittings, public appearances and in photo shoots, as determined by WVTM/NBC13 HD in its sole discretion.
- to make themselves available for an appearance on WVTM/NBC13 HD following the honeymoon, which may be live or pre-recorded, in WVTM/NBC13 HD's sole discretion; and
- to make themselves exclusively available to WVTM/NBC13 HD for all other publicity and promotion and not to allow interviews by other media outlets, including television, magazines, newspapers, radio, and internet, unless authorized by WVTM/NBC13 HD, from the time the Wedding Couple is announced, until after the final on-air appearance by the Wedding Couple.

5. ADDITIONAL WEDDING COUPLE OBLIGATIONS

In addition to the obligations above, the Wedding Couple must be prepared to be legally married in a wedding to be organized by WVTM/NBC13 HD and recorded and broadcast on television. The wedding ceremony is currently scheduled for October 9, 2008 at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205, but the date and venue are subject to change in WVTM/NBC13 HD's sole discretion if it deems necessary. The Wedding Couple must agree that WVTM/NBC13 HD viewers, website users and others will select the significant elements of the wedding, such as: nature and length of ceremony, choice of wedding dress, groom's and wedding party attire, cake, flowers, music, wedding rings, and honeymoon itinerary (but not the honeymoon destination), and the Wedding Couple agrees to accept these choices and not to attempt to influence such choices. The Wedding Couple agrees that other elements will be furnished by and in the sole discretion of WVTM/NBC13 HD. The Wedding Couple acknowledges and agrees that WVTM/NBC13 HD may change any or all of these elements in its discretion if it deems necessary.

The Wedding Couple must be prepared to be married on WVTM/NBC13 HD on October 9, 2008 at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205 or such other date and venue chosen by WVTM/NBC13 HD in its sole discretion, and will be prepared to depart on a later date for a honeymoon destination that will be revealed on the day of the wedding. As noted above, the wedding ceremony is currently scheduled to take place Thursday, October 9, 2008 at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205. However, the date and venue are subject to change in the sole discretion of WVTM/ NBC13 HD.

6. WEDDING COUPLE SELECTION

On or about July 29, 2008, at approximately 5:00 pm, or within a reasonable time thereafter, a selection panel consisting of WVTM-TV LLC personnel will select the Wedding Couple and a Runner-Up Couple from all complete and timely entries received, based on the following equally weighted criteria as determined from each couple's Video and Application Materials:

- The aesthetic appeal of the couple;
- The uniqueness of the couple's history and background (how each couple met, how they became engaged, how long they have been engaged, the relationship of the couple with family and friends, etc.);
- The personality of each entrant, individually and as a couple;
- The couple's ability to articulate their story;
- The couple's interaction with one another; and
- The demonstrated strength of the couple's commitment.

The Wedding Couple will be required to complete and sign an Affidavit of Eligibility, Waiver of Liability and Publicity Release in the form attached to these rules or otherwise furnished by WVTM\NBC13 HD. The Wedding Couple may be required to sign other documents, including tax documents.

If the Wedding Couple is disqualified or ineligible, declines or refuses to accept the Grand Prize, or is otherwise unable or unwilling to fulfill their obligations as outlined in these Official Rules, the Runner-Up Couple will be declared the Wedding Couple. In the event that the Runner-Up Couple is disqualified or ineligible, declines or refuses to accept the Grand Prize, or is otherwise unable or unwilling to fulfill their obligations as outlined in these Official Rules, one Alternate Couple will be selected. In the event that the Alternate Couple is disqualified or ineligible, declines or refuses to accept the Grand Prize, or is otherwise unable or unwilling to fulfill their obligations as outlined in these Official Rules, the Grand Prize will not be awarded. The Runner-Up Couple and the Alternate Couple will be subject to all eligibility requirements and other restrictions in these rules.

All decisions of the judges are final and entrants agree to be bound by these decisions.

7. SELECTION OF WEDDING ELEMENTS

Once selected, the Wedding Couple will appear on WVTM/NBC13 HD, if requested by WVTM/NBC13 HD, up to twice a week for up to 16 weeks, for taping of WVTM/NBC13 HD on-air segments devoted to wedding planning. WVTM/NBC13 HD currently intends these segments shall be in Birmingham on the Wednesday of each week, but location and dates are subject to change at WVTM/NBC13 HD's discretion. Some weekly segments may predate the selection of the Wedding Couple.

Each weekly segment will be devoted to one aspect of wedding planning such as wedding attire, cake, wedding rings, and the like and will feature a number of examples of such elements of a wedding. For example, the bridal gown segment may feature a number of gowns by a number of designers. After each such segment, WVTM/NBC13 HD shall select some choices and post them on the WVTM\NBC13 HD website (usually by 10:00 am CT that day). Viewers then will have an opportunity to vote for one of the designated choices, until the voting deadline announced on air and on the web site. The item or element that receives the most votes during the applicable

online voting segment will be selected for the WVTM/NBC13 HD wedding. No substitution or exchange of these elements will be permitted, except that WVTM/NBC13 HD may substitute an element of equal or comparable value if it deems necessary, in its sole discretion. *(The wedding venue and honeymoon destination will not be the subject of public voting and will be selected by WVTM/NBC13 HD in its sole discretion).*

THE WEDDING COUPLE MUST AGREE NOT TO DISCLOSE PUBLICLY THEIR PREFERRED CHOICES OR TO OTHERWISE ATTEMPT TO INFLUENCE OR MANIPULATE VIEWERS' VOTES FOR ANY OF THE ELEMENTS OF THE WEDDING.

8. GRAND PRIZE (WEDDING, HONEYMOON, AND 2-YEAR VEHICLE LEASE)

The Grand Prize, which has an approximate retail value of \$25,000, will consist of the following elements:

- (a) A wedding recorded for broadcast consisting of:
- A wedding ceremony officiated at the Donnelly House, 2838 Highland Avenue, South, Birmingham AL 35205 on October 9, 2008 at 2:00 pm, or such other venue and time to be determined by WVTM/NBC13 HD by a person selected by WVTM/NBC13 HD or by an individual chosen by the Wedding Couple and approved by WVTM/NBC13 HD, provided that such individual is legally authorized to perform marriages in the location selected by WVTM/NBC13 HD for the wedding ceremony;
 - wedding attire for the bride and groom (groom's outfit may be rented);
 - hairstyling for the bride;
 - wedding attire for the wedding party, including up to 5 people on each side, as follows: on the bride's sides – the bride and up to 4 attendants, one of whom may be a flower girl. On the groom's side – the groom and up to 4 groom's attendants, one of whom may be a ring bearer (certain outfits may be rented);
 - wedding invitations;
 - wedding flowers;
 - wedding music;
 - wedding reception designed by WVTM/NBC13 HD;
 - wedding cake;
 - wedding rings; and
 - transportation to and from the honeymoon venue, which may be to and from the nearest commercial airport or seaport or vehicle rental company. Ground transportation to and from Wedding Couple's residence as well as ground transportation at the honeymoon venue will not be provided.

WVTM/NBC13 HD in its sole discretion shall determine and/or approve the length, content and nature of the wedding ceremony, with emphasis on the demands of recording an event to be broadcast on television. WVTM/NBC13 HD reserves the right at its sole discretion to limit the total number of attendees for both the wedding & reception. A minimum of 50 attendees and a maximum number of 150 attendees will be the standard set limits for the wedding and reception. Additional or different features or participants may be requested by the Wedding Couple, but are

subject to approval by WVTM/NBC13 HD in its discretion and additional costs for such items (if approved) will be Wedding Couple's sole responsibility.

(b) A minimum three night honeymoon for the bride and groom at a destination that shall be revealed by WVTM\NBC13 HD on the day of the wedding.

(c) A 2-year Ford Credit Red Carpet lease on a 2008 Lincoln Automobile. The lease has an approximate retail value between \$15,000 and \$25,000. The Wedding Couple is solely responsible for all applicable taxes, insurance costs, surcharges, registration, title, excess mileage, and license fees and other costs incurred in claiming, registering or using the vehicle, and operating and maintaining the vehicle. Vehicle includes standard features; any additional options, if available, are the Wedding Couple's responsibility. Interior and exterior color of vehicle is subject to availability and at the sole discretion of the Sponsors. The Wedding Couple will be required to personally retrieve the vehicle from a local dealership or location as determined by Sponsors and at that time will need to provide valid driver's license, proof of insurance sufficient under the terms of the lease agreement, registration and any necessary fees as outlined above. Vehicle will be leased to the member of the Wedding Couple who is designated in the Entry Form as the Captain and this person will be required to sign standard Ford Motor Company lease agreement.

9. PRIZE RESTRICTIONS:

Wedding Couple assumes sole responsibility for all costs associated with the prizes not explicitly outlined above, including but not limited to any and all other taxes, passport expenses, fees, surcharges on a prize, additional meals, alcoholic beverages, tips, gratuities, sightseeing, souvenirs, trip insurance, excursions, ground transportation not expressly described as part of the Grand Prize and incidentals. Honeymoon resort or venue may require credit card or cash deposit for incidentals. All federal, state and local income taxes (if any) are the sole responsibility of the Wedding Couple. Sponsors assume no liability or responsibility in connection with the safety or performance of any prize awarded hereunder nor in connection with any warranty or representation therewith except as provided by manufacturer. No substitution or cash redemption of the Grand Prize or any element thereof is permitted except that WVTM/NBC13 HD may substitute prize of equal or greater value if it deems necessary. In the event that the Wedding Couple does not accept or use all elements of the Grand Prize, such elements that are not accepted or used will be forfeit and the Wedding Couple will not be entitled to any cash or other compensation for the difference in value.

The wedding shall take place and honeymoon must be taken on dates and times designated by WVTM/NBC13 HD or Wedding Couple will forfeit the entire Grand Prize and the Runner-Up Couple will be selected by WVTM/NBC13 HD to receive the Grand Prize.

As a condition of attending the wedding ceremony, all members of the wedding party and other guests will be required to complete, without making any changes, a liability and publicity release in advance, which release will be supplied by WVTM/NBC13 HD. All travel and accommodations for honeymoon shall be determined by WVTM/NBC13 HD, in its sole discretion. WVTM/NBC13 HD reserves the right to provide ground or other transportation in lieu of air transportation. Other restrictions apply.

10. MISCELLANEOUS.

WVTM/NBC13 HD reserves the right to postpone or terminate the Contest or any component thereof, including without limitation, the Wedding Couple selection process, the online voting segments, the wedding or the honeymoon or cancel the broadcast of the wedding should any non-authorized intervention, network failure, information storage failure, telecommunications failure, malfunction, or other causes beyond its control, corrupt or impair the security, administration, fairness and/or operation of this Contest as determined by WVTM/NBC13 HD in its sole discretion. In such an event, WVTM/NBC13 HD will select the Wedding Couple from all non-suspect, eligible entries, utilizing the selection process and judging criteria set forth above.

Sponsors are not responsible for telecommunications, network, electronic, technical or computer failures of any kind, for inaccurate transcription of entry information, for errors in any promotional or marketing materials, for errors in these rules, for any human or electronic error, including but not limited to the administration of this Contest or the Grand Prize, or for Application Materials, that are stolen, misdirected, mutilated, illegible, garbled, delayed by computer transmissions, lost, late, damaged, unviewable (with respect to the Video) or postage due.

Caution: Any attempt by an entrant or any other individual to deliberately damage any online service or web site or undermine the legitimate operation of the Contest is a violation of criminal and civil laws and should such an attempt be made, WVTM/NBC13 HD reserves the right to seek damages and/or other remedies from any such person to the fullest extent permitted by law.

WVTM/NBC13 HD reserves the right to correct typographical or clerical errors in any Contest-related materials. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, WVTM/NBC13 HD reserves the right to award only the stated number of prizes in accordance with the selection criteria previously stated herein from among all legitimate, un-awarded, eligible prize claims.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrants and/or Sponsors in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state of Alabama, without giving effect to any choice of law or conflict of law rules that would cause the application of the laws of any jurisdiction other than the state of Alabama. Any legal claim or cause of action arising out of or relating to the Official Rules, or the promotion, administration or fulfillment of the Contest, shall be resolved exclusively by the courts of Jefferson County, Alabama.

11. PUBLICITY RELEASE

Acceptance of a prize constitutes permission (except where prohibited by law) to use the Wedding Couple's names, city, state, likenesses and/or voices for purposes of advertising, promotion and publicity without additional compensation and in any media, including on the Sponsors' web sites.

12. DISCLAIMER/LIMITATION OF LIABILITY

All entrants and participants assume all liability for any injury or damages caused or claimed to be caused by their participation in the Contest, including the acceptance, use and enjoyment of the Grand Prize, including the wedding, honeymoon and vehicle lease. All entrants and participants release Media General, Inc., its affiliate or subsidiaries, including but not limited to Birmingham Broadcasting (WVTM-TV), LLC, Ford Motor Company, and Birmingham Magazine, and their respective advertising and promotion agencies, their parent, subsidiary, affiliate and joint venture companies, as well as their respective officers, directors, and employees, from any such liability arising out of their participation in the Contest or their acceptance or use of the Grand Prize or any element thereof.
